



Women’s Golf League Information Sheet - EWGA LI 2010

\$60.00 League Fee (Non-Refundable) to join one or more leagues. In addition, you must submit the one-time **\$50 Security Deposit** to join an unlimited number of leagues. Members are responsible for green fees for any “No Shows” or “Late Cancellations.” Security Deposit is paid one time and rolls over year to year and will be refunded in total upon resignation from league play provided all greens fees are up-to-date. To the extent that any interest is earned on the security deposit, it shall be regarded as additional service cost payable to the Chapter and members will not be entitled to payment of such interest. **Green Fees** are due each week you play league. Pay as you play.

Information Checklist for 2010 EWGA-LI Leagues

Leagues: are exclusive to EWGA-LI members in good standing with National membership dues Paid in Full.

Application: must be completely filled out, signed and accompanied by Release and Indemnification Agreement with check made payable to EWGA Long Island. Applications received without payment, signature or Release and Indemnification Agreement will be rejected. New Members joining League Play for the first time will make out a check to EWGA-LI totaling \$110. Returning members in good standing will make out a check totaling \$60.

Memberships: You will receive confirmation of membership via e-mail and membership is only official upon acceptance by the League Committee.

9 Hole Weekly League Play: With the ability to play up to 18 holes, at no additional cost, daylight permitting and at the discretion of the starter is available at Cantiague, Eisenhower, Oyster Bay, Wind Watch and Harbor Links Champ leagues only. **Please note the change in days/time for Harbor Links Executive Beginner League.

18 Hole Weekly League Play: Only available Saturdays at Heatherwood and Sundays on the Travel League.

Mandatory Handicaps: Handicaps must be maintained at all non-beginner leagues. Members are responsible for entering all scores. If use of a system other than GLMS is employed, notification must be made to each league's scoring captain with member's number (please fill in space provided on application). Failure to maintain a handicap or notify the league where the handicap is maintained renders the member ineligible to receive any tournament awards.

20 Week Season beginning the week of May 4th running through the week of September 14th, 2010. Choice of league depends on day & level of play. Match Play distributes its own schedule and Travel League continues through the end of October.

League Fee: **\$60.00 Annual Administrative Fee** regardless of how many leagues you join. The \$60.00 Annual Administrative Fee is non-refundable for any reason or any time. Once paid with your application, it will not be refunded.

Security Deposit: **\$50** one-time fee which will roll over year to year. A full \$50 refund will be payable to any member upon resignation from league play provided all greens fees for any No Shows or Late Cancellations have been paid. To the extent that any interest is earned on the security deposit, it shall be regarded as additional service cost payable to the Chapter and members will not be entitled to payment of such interest. You hereby acknowledge that the Chapter is not under any obligation to pay interest on any security deposit held in connection with the leagues, regardless of the length of time it is held.

Greens Fees/Tee Times: Your green fees are due each week you play league. Pay as you play. Daily Greens Fees/Cart Fees vary for course – see Application (Greens Fees subject to change by course personnel). Tee-Times also vary per course – see opposite page. Tee-Times requested 1 week prior to play unless otherwise specified by Tee Time Captain.

Home Course: You must pick a Home Course (primary league). Your Home Course will be where you plan to play the most. You will automatically be allowed to participate in the League Championship for that league.

Multiple League Play: You may join as many additional leagues as you like. To participate in the League Championship for some additional leagues, you must play a minimum of six weeks excluding the Championship rounds. **Exception:** Harbor Links 9 Beginner, Heartland, Cantiague, Heatherwood & Cherry Creek. Only home course league members are eligible to play in those League Championship tournaments

Weekly Tournaments: Members can participate in weekly tournaments at their Home Course or some additional leagues they have joined **except** the beginner leagues. Only home course beginner league members are eligible to play in those tournaments. **EXCEPTION:** Everyone may participate in the two team tournaments.

****Match Play Leagues will distribute their own schedule of dates and tournaments.**

End of Season League and Awards Dinner: All league members will be invited to attend a dinner at the end of season to celebrate another great golf season with new friends and old ones. This is the night that the winners of the league tournaments and league championship receive their awards.

**EWGA CHAPTER EVENT RELEASE and INDEMNIFICATION
AGREEMENT**

I wish to participate in **League Play** being sponsored by the **EWGA-LI Chapter** and as a condition of being permitted to do so, I agree to be bound by the following conditions, terms and release.

I understand that golf is a sport requiring physical exertion, and may involve other individuals, flying projectiles, motorized vehicles and other unknown, unanticipated or unpredicted risks and or hazards, that may expose me to the risks of serious injury, permanent disability, or even death. I am fully aware of, and I assume, these risks.

I understand that the Chapter may or may not provide me with any assistance, guidance or training in the sport or the rules of the game and/or golf course being played, but that the Chapter's providing such (or not doing so) in no way affects, alters or modifies the terms I am agreeing to hereunder.

I recognize that the Chapter cannot control the conditions of the golf course; nor control the conduct of other individuals playing at the golf course or employees/staff on the golf course, or any other individuals (including other Event participants) or uninvited guests; nor otherwise reduce any risk to which I may be subject during any time period I am playing golf.

I acknowledge and recognize that my participation in the Event is voluntary and I undertake it at my own choosing and with a full understanding and awareness of the risks that it poses to me and to others.

I also certify that I am in adequate physical condition and fully capable of playing the game and undertaking any tasks that I choose to perform.

I further understand that the EWGA-LI Chapter posts its tee time schedules on its website, which can be accessed by the general public. To the extent that I need to request a special accommodation with regard to this practice, I understand that I can contact the League Chair in connection with this issue.

Accordingly, I hereby release and forever discharge the Chapter and the Executive Women's Golf Association, and their respective officers, directors, agents, and employees, acting officially or otherwise, from all liability, claims, demands, damages, expenses, actions or causes of action, resulting from my injury, disability, or death that may occur as a result of my participating in the Event or growing out of the negligence or misconduct of others, including but not limited to: other individuals playing at the golf course or employees/staff on the golf course, or any other individuals (including other Event participants) or uninvited guests; and I hereby indemnify and hold the Chapter and EWGA harmless with respect to any and all damages, claims, and other expenses (including attorneys' fees) incurred by the Chapter and EWGA in connection with any lawsuit related to my actions.

I further declare and represent that I have read and understand this release and that I have executed this release freely and voluntarily, and entirely upon my own initiative, and intend to assume all risk and responsibility for my actions.
